# **Minutes – February 6 MAG Board Meeting**

Approvel of Jan. minutes

1: Sales in January Showcase are good. Total sales of more than \$1700 among several artists were reported. Some of the 2012 yearbooks were distributed at Pick Up.

- 2: Cindy Koshalek sent out the remainder of the yearbooks on the mailing list. Thank you, Cindy! 150 yearbooks were ordered at cost of \$341.
- 3: Treasurer Susan Baez reports an \$11,003.49 balance as of 2/6/12.
- 4: Kris made the motion that an Art Fair on the Square subcommittee should be formed to develop a fair drawing procedure, seconded by Sue B. The subcommittee is comprised of Susan B, Kerri, Norma Koshalek and Cindy. They will meet in February and discuss new rules for the Art Fair and bring their recommendations to the Board on March 5.

Sue L. presented the motioned to allow a 4 x 1 foot banner with MAG's name on it to be purchased and used on the display tent for Art Fair on Square. Kerri seconded the motion. All approved this motion.

- 5: Susan L. and Kris are formulating a standardized policy and procedure booklet to make all members able to access this information on the web site. This will provide new members with guidance to questions regarding volunteering, the Salon, the Winter Showcase etc.
- 6: Sue L. and Kris will be the Summer Salon Chairs. They are directly contacting members to serve as committee chairs.
- 7: Beatrice Williams is willing to start printing the information that will be needed for the packets (Salon instructions and 4 part form). She will begin this after she receives her directory and updates the mailing list.
- 8: The MATC 2012 scholarship of \$420.00 was approved by the Board.
- 9: Pertaining to the request of the Leukemia-Lymphoma Society to be cosponsors of one of a series of events (involving responsibility for food), the motion was made by Norma H. that "MAG will make known requests for donations and provide art work accordingly, but will not sponsor events". It was seconded by Cindy. Approved by the Board.
- 10: Pucci's Gallery in Madison has been providing an opportunity for Guild members monthly display opportunities. Feb. is filled, but need more volunteers for March. Members who are interested, please contact Loretta Dooley at 608-271-7472 or peter@h2ocolorart.com
