ART FAIR ON THE SQUARE DRAWING – MAY 7;

DEADLINE TO APPLY – APRIL 18

Every MAG member is eligible to participate in the drawing for Art Fair on the Square.

Art Fair on the Square is a yearly event sponsored by the Madison Museum of Contemporary Art. Several Madison art groups are allowed booths to participate and must follow all the same rules as other exhibiting artists. In past years MAG has had two tents, which allows for six artists. This is a big show, intense, hot, busy and very fun and hopefully, profitable.

It takes a lot of preparation and hard work. Be prepared if you enter and win a spot. It involves having a sales permit, building adequate inventory, setting up and breaking down tents and your display area, and remaining adaptable to weather conditions. Many meetings are mandatory and everyone has a big responsibility. Depending on the booth fee charged by MMOCA, the individual portion of the booth fee is usually about \$175.

Once your name is drawn, if you drop out, you lose your space! Subsequent artists in line will move up if they can. Fees will be returned if spot is filled.

MINUTES – April 2 Board Meeting

- Only four people attended the Chazen Museum tour on Sunday, March 25.

- There is confusion about the Art Fair on the Square drawing. Some people think it is only for this coming year. Pam will send out a special e-mail, stating basic information for the drawing, and the article from the March newsletter plus the application form will be included in the April "Touching Base" issue.

- Discussion on how to reimburse members for printing costs for both the newsletter and Salon materials resulted in agreement that all printing should be in black and white, and reimbursement should be the going rate per page of what printing companies charge, i.e. 7 cents per sheet.

MINUTES – APRIL 2 MAG Board Meeting (continued)

- Salon planning is right on schedule. Eighty-six letters have been sent to area businesses soliciting donations for the Salon, the committee has met twice, Cindy Koshalek will order the postcards, and Norma Koshalek will create the award ribbons. Co-chairperson Sue Lewis presented a formula for determining the relative value of the awards for each category and type of award, which was developed by David Carpenter. Pam Andros moved that the award guidelines be accepted, and Susan seconded the motion. Motion passed unanimously.

- Treasurer's report – Susan reported that there is \$10,621.98 in the checking account. She has renewed the insurance policies.

- Pam shared information on the Power2Give program that is expected to launch in Dane County this summer. This is an online program that will match artists and donors. The Dane County Cultural Affairs Commission is looking for projects that might be eligible for funding assistance through the site

- Loretta Dooley reported that feedback on the Hilldale Art Fair, held March 31 & April 1, indicated that 80% of the participants were pleased. She stressed that artists must abide by the Hilldale hours: Saturday (10-9) and Sunday (11-6) with no exceptions. Those who do not stay for the entire show will be not be allowed to participate in future shows.

- Cindy proposed that MAG sponsor various galleries in 2014 as part of the MAG Centennial celebration. She volunteered to chair this aspect of the event.
