### MAG Board Minutes – June 11, 2012

The Board went through the list of non-participants and divided them up into excused and unexcused absences. Unexcused members will receive a letter stating that they can maintain inactive status if they pay dues by August 1<sup>st</sup> and do one volunteer job. A few members who can no longer participate due to medical issues beyond their control, will be offered honorary membership. A motion was made and passed to create the title of "honorary member". The intent of this membership is to enable long-time MAG members who want to continue membership but can no longer do so in an active way because of illness to sustain their membership. These members will not have to pay dues, and will not count as a member toward the maximum number of members allowed in MAG at any one time (aka the cap). Pam will send letters to both unexcused members and honorary members to inform them of their status.

A motion was also made and carried to change the membership dues due date from August  $1^{st}$  to the June Salon drop-off date. It was noted that the associated dates on pages 2 and 22 of the yearbook will have to change to reflect this change in due date.

Motion was made to add a statement to the next Salon packet that members will sign that they agree with the following statement: "artwork must be original, completed within the last 2 years, and has not been shown before at a MAG salon." The motion was made and carried with one dissenting vote.

AFOS - MMOCA informed us that the booths for the 2012 AFOS are #219 and 221. This arrangement will allow space on one side for a display of the MAG sign and additional shared display space. The booth should provide good advertising for our organization.

Yearbook:

The board reviewed a few alternatives for the policy for the yearbook cover art and decided on using the previous year's Best of Show winning artwork for the cover. If the cost of a color cover is affordable, we will go with a color cover. If not, we will choose Best of Show if

if it prints well in black and white, and if not, choose among the other prize winners for work that will look good in black and white. We feel confident that color printing for the cover only will be affordable. A motion was made to go with this option and all agreed.

Officer terms – all terms end in October at the fall dinner/annual meeting. Kerri Shannon resigned from her position as secretary starting in June because she will be out of town for the entire summer. Substituting for her will be one of the volunteer tasks offered to unexcused members who did not participate in the Salon. The remaining officers will have to cover the job until a new secretary is put in place.

Next meeting agenda – 1) Proposed changes to bylaws; 2) jurying for new membership – date set at August 18<sup>th</sup> at the Sequoya Library; 3) Fall dinner/annual meeting – date set for Thursday, October 18<sup>th</sup>. Cindy suggested and will call Imperial Palace on University Avenue, and it will be best for each person to order individually off the menu, as we have done in the past.; 4) establish nominating committee for new officers.

Meghan Blake-Horst, owner of Absolutely Art has contacted MAG to invite "galleries, artists, art guilds and absolutely everyone involved in craft to present events, such as studio tours, art walks, fairs and special exhibitions during American Craft Week." Now in its third year, ACW begins the first Friday in October and runs for ten days. In 2011, more than four hundred locations held special events highlighting fine art and craft artists. Participation fees start as low as \$25 to help cover the cost of print materials.

## **Arts and Economic Prosperity**

Pam Andros reports that a recent study shows a positive impact of arts on local economy. Here's valuable information to help make the case that the arts create jobs, businesses, inspiration, community, and so much more!

June 2012: Americans for the Arts and the Wisconsin Arts Board have released *Arts and Economic Prosperity IV*, providing new data on the state of the nonprofit arts industry nationally and statewide. The study reveals that in Wisconsin, **local nonprofit arts organizations generate \$535 million in economic activity annually**, resulting in nearly \$65 million in local and state tax revenues, 22,872 in full-time equivalent jobs and \$479 million in resident income.
