Advanced Notice Regarding Several Changes in Procedures and Dues for 2013 MAG Summer Salon - *Please read carefully*

- 1) The Salon Registration Packets will be mailed to non-computer users in early April; *all other members will receive their Salon Information by email.* If you do not receive the Salon Registration information by April 30th, please contact David Carpenter, <u>dcarpenter3@charter.net</u> or phone: (608) 442-6958.
- 2) The Salon Fee for 2013 will be \$15—this is an increase of \$5. On Jan. 15, 2013, the MAG Board voted to increase the Salon Fee in order to fund monetary awards for each Salon Award.
- 3) Dues and the Salon Fee will not be collected at the Salon Intake, as in the past. Rather, *MAG* annual dues (\$30) AND the Salon Fee (\$15), along with the Salon Registration Materials, must be mailed back to the Salon Committee by May 10, 2013.
- 4) One check (\$45) to cover both the Annual Dues (\$30) and the Salon Fee (\$15) is acceptable. A pre-addressed envelope will be included in the Salon Packet. (Those members who have moved into the "Honorary Membership" status will not receive a Salon Packet; Honorary Members will not be required to pay annual membership dues).



5) Members who have requested, and received, Board approval to not participate in the 2013 Salon will still be required to mail annual MAG dues (\$30) back by May 10, 2013 (along with the non-participation form that will be included in the Salon Packet.)

CALL TO ORDER: CO-PRESIDENTS' REPORT

- Meriter Friends 4 Friends Gift: First gathering was held & 40 kits were put together and delivered to Hospice. Another meeting is planned for later in the summer. Article about the project will be put on our website and Meriter and Hospice will be publicizing the project.
- Sympathy card was sent to family of Jean McCormick. A memorial is being set up by friends and MAG will determine its use in the future.
- WI Nonstock Corporation Form filed, three more forms are due in the next 3 months.

Standing Reports:

- 1. *Treasurer's Report:* Tom Kuchenbecker purchased \$5,000 CD for MAG. Current balance \$6,422.42. Five sales were made from the January Showcase with 5% going to MAG.
 - Insurance for Directors and Officers: This is a policy to protect MAG Officers against liability suits. MAG can opt for a 3 year contract to lock in prices. Norma Hove made a motion to renew the D & O Insurance for 3 yr period of time, David Carpenter seconded the motion, motion passed. Kris Kellor will follow through on the paperwork, due April.
 - Yearbook costs were about \$500. Tom proposes that we move toward digital format available on the website. Members who do not have internet access will be sent a paper version. Ruth Manning made a motion to create the MAG Yearbook digitally rather than printed and make it available via the website, Cindy Koshalek seconded it, the motion passed.

2. Newsletter Report:

Progress on e-Newsletter: Norma H. and Tamara Tsurkan continue to work on the e-Newsletter. Tamara showed an example of a possible format for the newsletter on the website. Members will get an email saying the newsletter is available on the website. Board discussed possibilities for increasing the number of artists who submit images for the website



in the "Artists" section.

3. Membership Report:

Jury Date for new members: Cindy will arrange date for April at Sequoya Library and let Norma know for the Newsletter.

- 4. **2013** Art Fair on the Square Chair Kathy Winter's Report: All checks have been turned in and the booth fee to MMOCA was mailed. Kathy indicated in a written report that she has not received word yet regarding acceptance of MAG members into the 2013 AFOS.
- 5. **Yearbook Report:** Distribution is done and the remaining yearbooks were mailed.

Continuing And New Business:

1. Salon Committee Update:

- Submission of Judge Candidate for Board Approval: John Ribble, MATC faculty and ASOF judge, has been contacted. Dave made a motion to hire John Ribble for the Salon judge, Chris seconded the motion, motion passed.
- Judging Guidelines: Guidelines and Categories for judging the Salon. Sue will be putting this together in the next two weeks and will send it out to the Board before she sends it to John.
- Dave handed out a timeline for the MAG Salon Schedule. Mailing will be done electronically. A list of volunteer needs was discussed and logistics reviewed for Salon packets and procedures. Dave is still looking for a volunteer to oversee the reception.

2. Centennial Committee Report:

Committee met prior to Board Meeting to begin initial brainstorming for the year's celebration. MAG is looking at a variety of show possibilities throughout the year. Group is planning to meet again in March and April at 5:30pm prior to Board Meeting.

- Volunteer still needed to help with MAG equipment rental site key and coordination of equipment rental.
- 4. Hilldale Exhibit Update: Chris Echtner reports Hilldale staff has been very supportive and making requests for new brochures as needed. MAG is currently presenting its 3rd rotation in the space. There were multiple sales (6-7) of original art in Rotation Two.
