## Salon Packets Have Been Mailed

If you have not received your Salon Packet by email (or by U.S. mail for those who do not use computers), please check your email dated April 7 to find it. The Salon procedure is changing this year:

 the Registration Card, membership dues and Salon dues (one check only, made out to <u>MADISON ART GUILD</u>, for both dues) must be mailed to David Carpenter, 53 Cherokee Circle -#201, Madison, WI 53704 by May 10,

**2)** MAG members will bring artwork with the Identification Card (from the Salon Packet) attached to UW Hospital & Clinics on Saturday, June 8, 9:00 to 11:00 am., and

**3)** Wall identification cards will be typed in advance of Intake, so last-minute changes will cause considerable confusion.

MAG is shifting to a better organized method of intake, and it will take everyone's cooperation to make this work. Participation is the one **mandatory** expectation of every member each year...only those members who have health problems and extreme extenuating circumstances



are excused. Screening for artwork that was created before 2011 will also be conducted at Intake, since the requirement is that all artwork in the Salon must have been created within the past two years. If any artwork is inadvertently included in the Salon that is later found to be older than two years, the judge will be instructed to exclude these works from those considered for awards.

#### CALL TO ORDER: CO-PRESIDENTS' REPORT

#### Standing Reports:

 Co-Presidents' Report: Kris Kellor and Sue Lewis would like to discuss the future scope and responsibilities MAG will be taking on in the upcoming year including possible Centennial Activities, Facebook page and expansion of website use. Projects such as the MAG Directory online will necessitate additional help. There is a need for additional members to assume leadership responsibility for short-term and long-term projects.

In particular, please let the Board know of others in MAG who may have expertise in the computer field and would like to be part of a committee to assist Tamara.

Sun Prairie Emergency Food Pantry sent a thank you note for donations of food collected at the January Showcase by MAG.

- 2. *Treasurer's Report:* Tom Kuchenbecker reports \$5,390 on hand. Moneys were paid out to insurance policies, PO Box fee and Hospice supplies in March. Tom requests he reimburse MAG members in person to save on postage. Tom will be keeping a separate membership ledger of dues to keep a better account of the membership each year.
- 3. *Newsletter Report:* Norma Hove reports that the procedure to produce and post the newsletter online has continued to work well. Norma reminded the Board we need to be



aware of the timeliness of articles. Kris and Sue will meet with Tamara prior to the May meeting to assess the newsletter workload and how we should move forward.

- Membership Report: Cindy Koshalek reports jurying for new members will be at the Verona Library May 4th. Fifteen people have expressed interest in submitting work. Cindy will print out a Salon packet to enclose in the acceptance letter for the new members.
- 5. **2013 AFOS Chairs Report:** Kathy Winters reports we received an email to say MAG is accepted into the show and reported this news to participants for both this and next year. Norma Koshalek had the Board draw for positions for 2016.
- 6. **Centennial Committee Report:** Cindy K reports that the Coffee Gallerie has been lined up for March 2014 for a two-month show.

#### Continuing And New Business:

1. *Hilldale Exhibit Update:* Chris Echtner reports Rotation 3 ends April 17 and Rotation 4 starts April 22 and will include Gallery Night. Chris requested money for refreshments from the Board. David C. made a motion that the committee submit a bill to the Board after the expenditure, Judy seconded the motion, motion passed. An addendum brought forward by Cindy K to put a cap of \$30 on the expenditure, the addendum was passed.

#### 2. 2013 Summer Salon:

a. *David C. update* - Committee met, and Salon packets were emailed (or mailed to those without internet access) ahead of schedule and 11 have been returned at this time. Deadline is May 10<sup>th</sup>. Most Salon Committee positions have been filled.

b. *Membership Cards* - Sue will print one year's worth of membership cards for the Guild based on the updated membership list after the May 10<sup>th</sup> dues deadline.

3. *Allin Scholarship Fund Status:* Tom K. reports there is \$95 left in the fund. If feedback regarding people who can't afford dues comes to the Board's attention we will address it at that point.



4. Overture Application Status: Judy and Dave Peterson filed the application on April 2. Dave P. made a CD of all work and papers submitted, which he gave to Sue. Dave noted you can't apply more than once every two years. Overture's decision will be made early in June.
