*MAG ByLaws Article II-Officers

Section A. Selection of Officers

1. Elected Officers

The elected offices of MAG shall be: President, Vice-president, Secretary, and Treasurer. The nominating committee shall be responsible for the slate of candidates for elected office. Officers shall be elected at the annual meeting or a special meeting.

2. Terms

Each officer elected shall serve a term of two years. The Vice-president shall succeed the President at the end of her/his term. At the end of the President's term s/he shall become Past President and shall serve a two year term as a member of the Executive Committee. Officers and the past President may serve for consecutive terms if they are re-elected.

3. Resignations and Vacancies

If an officer is unable or unwilling to complete her/his term, the Executive Committee shall appoint a replacement.

The estimated cost per artist per session would be \$15 to \$20. Evolution Arts Collective would provide the studio and model. It is located at 202 S. Dickinson St. in Madison, two blocks north of Williamson St. There is parking on site and on the street.

Call to Order:

1. Treasurer's Report

Tom K. reported a balance on hand as of May 1 of \$11,460 plus the \$5,000 CD. MAG has received a thank you letter from MATC scholarship recipient Amy Shane. Chris E will contact Amy and invite her to the Salon reception. Tom has begun to receive checks from the Salon registration.

2. Membership Report

Chris E. reports that she has had 15 people contact her regarding membership in MAG. Membership jurying will be held in September. An email has been sent out to the membership for "Art Night", an event designed to encourage members to gather and discuss their work on a monthly basis.

3. Centennial Committee

David received an email from Absolutely Art to inform us the business was closing. Meghan will continue to accept applications for the show to be displayed at Café Zoma. Applications will be filled out as usual and number of pieces accepted will likely be reduced.

Cindy K reports there are 24 artists accepted into the MOWA show. Ruth H will contact Cindy about transportation of the art to West Bend. Ruth will put an article in the newsletter with pertinent information. August 7 is the reception, 5-8pm.

- 4. MAG Directory Update Updates have been made to the master list and reported to the membership chairman.
- 5. AFOS Update

Judi reports that the group met May 6. Aileen and Judi are working on covers for the panels to be placed in the space. The tent has been repaired. Judi will contact future participants to remind them they need to help at AFOS 2014 set up and take down. A new AFOS drawing will be organized for Fall 2014.

6. 2014 Summer Salon
