## **Proposed Revisions to the Madison Art Guild Bylaws**

## **Recommended by the Board of Directors, September 16, 2014**

The following will be printed out and available to members for review, discussion and vote at the Fall Banquet:

#### **CURRENT STATEMENT**

**ARTICLE I – MEMBERSHIP** 

Section B. Types of Membership

1. Active Membership:

An Active Member shall enter one, recent, original art work not previously submitted, nor shown in any local juried exhibition, in the annual juried MAG Salon show. If an Active Member fails to do so, he/she may not participate in the Salon or other MAG events during the following year (June through May). To maintain active status a MAG member shall pay annual dues and participate in the current year's program as set by the Board of Directors. In addition, a new member shall volunteer and complete at least one task during the year after the initial jurying.

#### PROPOSED STATEMENT

ARTICLE I – MEMBERSHIP

Section B. Types of Membership

1. Active Membership:

An Active Member shall enter one, recent, original art work not previously submitted, nor shown in any local juried exhibition, in the MAG Salon or another MAG sponsored exhibition instead of, or in addition to Art Fair on the Square, at least annually. If an Active Member fails to do so, he/she reverts to inactive status, provided annual dues have been paid. In addition, a new member shall volunteer and complete at least one task during the year after the initial jurying.

#### **CURRENT STATEMENT**

ARTICLE I – MEMBERSHIP

Section B. Types of Membership

2. Inactive Status Membership:

Those members who do not plan to be active in the year's program may request to change to inactive status for up to two years. MAG members in inactive status shall pay dues but may not participate in MAG events and shows. Inactive members may return to active membership without having to reapply for full membership upon request to the Executive Committee.



#### PROPOSED STATEMENT

ARTICLE I – MEMBERSHIP Section B. Types of Membership

2. Inactive Membership:

Those members who do not take an active part in the year's program will revert to inactive status for up to two years. MAG members in inactive status shall pay dues and may participate in MAG events and shows except for Art Fair on the Square. Inactive Members may thereby return to Active Membership without having to reapply for Active Membership.

#### **CURRENT STATEMENT**

ARTICLE I – MEMBERSHIP

Section B. Types of Membership

4. Exceptions:

Any member who finds it impossible in any year to submit art work for the Salon show shall make written application to the MAG President or other designee of the Executive Committee stating reasons for his/her request to be excused from exhibiting that year. Examples of acceptable reasons for non-participation are health, family emergencies or extreme extenuating circumstances.

#### PROPOSED STATEMENT

ARTICLE I – MEMBERSHIP
Section B. Types of Membership
4. Exceptions:
<u>Eliminate.</u> Membership becomes self regulating by the previous amendments so there will be no exceptions.

#### **CURRENT STATEMENT**

ARTICLE VII – DUES Section B. Deadline for Payment Dues must be paid by the deadline date for the return of Salon Registration information in May of each year. However, new members being juried in September shall pay prorated annual dues upon notice of acceptance into MAG.

#### PROPOSED STATEMENT

ARTICLE VII – DUES

Section B. Deadline for Payment

Dues must be paid by June 30 of each year, except for Honorary Members. However, new members being juried in September shall pay prorated annual dues upon notice of acceptance into MAG.
