## **MAG Bi-Monthly Meeting Minutes**

Tuesday, July 9, 2019 at Sequoia Library, 6:30pm

### Welcome – Chris and Karen

Karen mentioned a new art venue in Middleton. "Art & Soul" at St Luke's Church is accepting artwork for exhibit. More information will be announced in the newsletter.

### Treasurer's Report - Tom

Tom reported that, as of 7/1, MAG's balance for checking and CD totaled \$10, 574.68. \$54 was paid for our State Charitable Organization license renewal. Three books of stamps were purchased for \$33. Expenses for this year's Salon were \$1,997 plus the cost of replacing two ribbons. This was only a few dollars more than last year's expenses.

Tom was contacted by Gigi's Playhouse, a Down Syndrome Achievement Center in Madison. They are requesting donations of artwork for their October fundraising auction. Information will be included in the newsletter.

### Salon Reception/Theft - Colette

MAG's June 1<sup>st</sup> drop off at the hospital was plagued with unexpected construction delays and confusion. With the efforts of Mandy Kron and help from our volunteers, 93 entries were eventually installed. Colette reported that the reception on June 9<sup>th</sup> was well attended with over 90 members and guests. All but 2 of the 22 award winners were present. To date, 9 pieces have been sold. It was noted that the hospital sound system, which was not functioning at full volume, was further impeded by segregated lobby seating. The possibility of folding chairs for next year was discussed. It was also suggested that information about the donors of our memorial awards be included in the program and mentioned at the time of the awards.

Colette presented details regarding several recent thefts of artwork at the UW Hospital, including one from MAG's exhibit. Fortunately, police were able to identify the thief and recover 5 of 8 stolen artworks. The MAG piece was recovered. In a separate incident, two of our ribbons were stolen. We have ordered replacements.

#### AFOS – Chris (via Steve)

The 3-D displays are ready and the 3-D artists have chosen their preferred set-ups. Chris brought samples of the display to demonstrate their multiuse. Chris will make a sign with the MAG statement and purchase a holder with a pocket for our brochures. Only one bin is allowed per 2-D artist.

There was discussion about the rules for applying for AFOS and for the MMoCA show. The consensus was that a member cannot be in both within the same year. The length of time before reapplying for the AFOS lottery was in question and Chris will check the by-laws for clarification. It was suggested that in order to be in the lottery, members must have participated in some volunteer activity or have been on some committee.

Terry Sullivan will continue to set up and take down the tent at this year's MMoCA event.

The Racine trip is on schedule with 8-9 people signed up.

#### New Member Jurying/Library Rule Change – Theresa

Theresa reported that the new member jurying is scheduled for the first Saturday in September at the Meadowridge Library. She noted a change regarding library rules which requires that any meeting held in one of the large rooms must be open to the public. This means that passersby can view artwork during the jurying, but they must be quiet. Artists whose work is being juried cannot be present. Theresa asked that MAG members urge other artists to apply for membership. She will post a notice on the site for Madison artists and will pursue a public service announcement on local television stations.

#### Finding Volunteers - Chris and Karen

Andrea suggested sending out email blasts as a different approach to requesting volunteers. She plans to send out an email requesting members for a new committee that will oversee all open MAG positions. Andrea also offered to establish and maintain a spreadsheet for tracking member participation.

Chris and Karen decided that our annual dinner will remain at Vintage. They will establish an October date and work on a specific menu.

The next board meeting will be Tuesday, September 10<sup>th</sup>, 6:30 at the Sequoia Library.
