## **MAG Virtual Show : Call for Artists**

We will again be holding a virtual art show & fundraiser. This year we will be raising funds for <u>Little Picassos</u> - a free art enrichment program for low-income children in Madison, WI. The show will run from April 1 through May 15<sup>th</sup>.

Deadline to commit to participating in this event is February 15<sup>th</sup>.

Once we know how many artists want to participate, we will notify them to let them know how many items they may submit. We have space for 100 art pieces. We are using the 32 Auctions platform this year so artists will be able to submit 1 to 4 images for each art piece and we will be able to take payments online via PayPal. There is no entry fee for this event, but participating artists will pay a 20% commission on sales which will cover a



minimum 10% donation to Little Picassos, the 32 Auctions and PayPal transaction fees, and advertising costs. Artists can choose to have a greater % of their sales go to Little Picassos. Delivery arrangements will still be the responsibility of the artist.

1) Treasurer's Report-

Discussion on the submitted Treasurer's report including the Fagerstrom Memorial, MAG expenses, and seeking insurance quotes from non profit insurance alliances/ brokers.

2) Standing Committees

Vice President Paul Nelson is looking into new opportunities and defining what Standing Committees are. Creating new emails for Committees.

Linda Krantz is not getting new member emails. Will check with Nate about new member emails. Virtual email is not set up.

#### 4) New Members - Linda Krantz

We lost 14 members which is about 13%.

One person became an honorary member. The rest did not renew for various reasons.

Calling non renewing members was suggested to find out why they didn't renew.

A list of members who did not renew their dues was read by the Treasurer.

Various methods to increase membership and make MAG more attractive were discussed.

Linda has written a proposal suggesting that MAG add Associate Member for 18 years or older. Associate

members would pay dues, but not receive full member benefits, such as exhibiting at shows.

Linda suggested an increase for the new jury fee to \$20.

There will be no new member jurying this Spring.

There are no caps on MAG membership .

Paul Nelson (VP) is in charge of by law changes.

#### 5) Ann Kleckner - Virtual Art Show

Ann has met with Mike Owen, Colette Girard and Andrea Murray to discuss the Virtual Art show for Spring. There are concerns about how much work it was last year. Looking at 32 Auctions as the platform for the online sale of artwork to benefit the Little Picassos charity. Discussion on promoting the online show through the charity and artist's contacts. 10% goes to the charity and a percentage will go to the artist. Budget is \$120 plus an extra \$30 for Firestorm advertising on Facebook. Total is \$150. Specific details and dates are forthcoming. Karen Watson Newlin made a motion to create the Virtual show/sale with 32 auctions, a budget up to \$150 and with the commission rate to be determined by Ann.

A second was by Colette Girard

A hand vote was taken, the motion passed unanimously.

#### **Executive Committee Minutes**

MAG Executive Committee Meeting - Minutes December 14, 2021 6:30pm

A special meeting of the MAG Executive Committee was convened by the President. In attendance: Dave Williams (President), Paul Nelson (Vice-President), Mary Reines (Treasurer), Cindy Koshalek and Colette Girard (Co-Secretaries), Karen Watson Newlin and Chris Echtner (Co-Past Presidents).

The primary purpose of this meeting was to address discrepancies between information listed on the MAG website and information stated in the current MAG By-Laws. The goal was to more clearly define leadership roles, standing committee definitions and responsibilities, sub-committee definitions and to determine voting rights.

It was discussed and decided that if a MAG leadership position is co-chaired, each chair will have a vote. Creating additional opportunity for input might encourage more members to volunteer.
Overseeing the Annual Dinner was determined to require more than one person.
A committee should be formed.

- A "You Tube" channel would be a good addition to MAG's current social media.

- It was suggested that the New Membership committee be merged with Membership

- Although a list of tasks and responsibilities for committee chairs currently exists, it was suggested that those lists be reviewed and upgraded as needed. As Vice-President, Paul will be responsible for reviewing the lists, noting overlaps between committees, and finalizing the list of duties for chairs/co-chairs. He will then post the final document for review. Terminology for committee heads should be consistent (coordinators vs chairs). The membership should have access to this information in the user area of the website when all task lists are finalized.

- New committees were proposed.

"Publicity": PR, outreach, partnerships, pitch document, publications.



"Opportunity Development": E-commerce, sponsors, partnerships, workshops, additional shows/galleries.

Follow-up to the executive committee meeting will be discussed at the January Board Meeting. Proposals which require membership vote will be addressed at the Annual Dinner.
